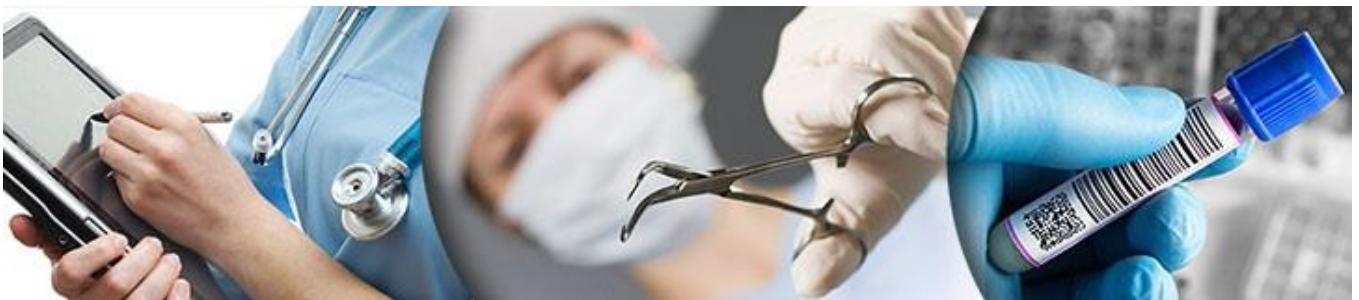

UDI

UDI is the worldwide project initiated by the International Medical Device Regulars Forum (IMDRF) and its member states, including Great Britain. The project is targeting to increase patient safety and efficiency of hospitals by unique identification of medical devices and IVDs. It includes the responsibilities of the suppliers for unique data on product and in the globally accessible data base but includes the responsibilities of the hospitals as well to use UDI to increase its efficiency and transparency. The half a day workshop will discuss what UDI is and how it can be freely used. Participants will get the opportunity to learn how to get the optimum out of the UDI project on the long run.
